EnviroCon(tm) is EPA registered. EnviroCon(tm) provides effective microbial control of *Evaporator Coils, Drip Pans* and *Associated Air Conditioning Parts*.

EnviroCon(tm) **eliminates** odors where they exist.

EnviroCon(tm) requires no activation.

EnviroCon(tm) is available in *Light Mint Scent* and *Unscented* and contains no alcohol, perfumes, or odor-masking agents.

EnviroCon(tm) possesses a low toxicity category assigned by the EPA (Category III).

MICROBIAL CONTROL

Bacteria, mold, mildew, fungi and *yeasts* are everywhere in our everyday environment. For many allergy sufferers, microbial growth in the air handling system can significantly aggravate or even initiate an allergic response. For this reason we have developed EnviroCon(tm), an EPA registered *Bacteriostat, Fungistat, Germistat* and *All-purpose Deodorizer*. EnviroCon(tm) may be used wherever air needs to be treated or on the cooling coils, drip pans and other associated air conditioning parts and duct work, including all indoor environments. It not only controls the growth of microorganisms, but eliminates the unpleasant odors that are the result of this microbial growth.

DEODORIZATION

The powerful active ingredient in EnviroCon(tm) oxidizes odors associated with bacteria, mold, mildew, smoke, animals, etc. in the air and in air handling units. EnviroCon(tm) does not cover up or mask the odor with alcohol or perfumes. It eliminates the source of the odor, leaving your air fresh and clean.

EnviroCon(tm) is available in unscented form or with a light mint scent.

TOXICITY & SAFETY

The most significant feature of EnviroCon(tm) is the low toxicity and safety of the product. EnviroCon(tm) has been assigned an acute toxicity rating of Category III by the EPA. This requires the EnviroCon(tm) label to carry only a precautionary statement of "*Caution*". By comparison a Category I rating, denoting the highest acute toxicity, requires a "*Danger*" statement while a Category II rating requires a "*Warning*" statement. In addition, EnviroCon(tm) is not an aerosol and contains no environmentally damaging propellants or flammable ingredients. EnviroCon(tm) treatments may be applied to occupied spaces.

APPLICATION

EnviroCon^(tm) may be used in all building HVAC systems -- residential, commercial, industrial and health facilities. It is easily applied with the use of a hand held fogger or air driven sprayer. All Hvac surfaces should be pre-cleaned prior to application. To control odors associated with bacteria, mold, mildew, animals, smoke, etc., thoroughly spray source of odor with **EnviroCon^(tm)** and spray a light mist in the air. For year round maintenance of the HVAC system, residential homes and apartment complexes should be treated as needed. Commercial, industrial buildings and health care facilities should be treated every month to ensure effective environmental control.
